- Bill Bogantz stated the bee removal is finished.

New Business

- Bill Bogantz asked Eric Zigo to give an estimate on painting the outside of township building.
- Bill Siegel made a motion to adopt the Resolution to Request that the County Auditor Certify Valuation and Revenue Information Pursuant to R.C. 5705.03 (B). David Cole seconded the motion. The motion passed with all yes votes.





Correspondence/Warrants/Receipts
